## **Decision:**

- **1.** It was reported that the Hon'ble Vice-Chancellor, NBU had meetings on NAAC accreditation preparation on 05.02.2013.
- 2. It was reported that the Hon'ble Vice-Chancellor, NBU had meeting with all the Heads of Faculty of Arts, Commerce & Law, and Faculty of Science on 16.04.2013 separately and discussed the issues related to mandatory accreditation of HEIS.
