The below note was circulated regarding International Visiting Professors' Scheme, University of North Bengal

As conceptualized by Prof. Om Prakash Mishra, the Hon'ble Vice-Chancellor of the University of North Bengal (NBU), the University has taken the initiative of inviting Professors and Scholars of eminence under the International Visiting Professors' Scheme. The scheme envisions to benefit from the knowledge and exposure of the eminent scholars and teachers in various disciplines.

A Committee of eminent academician was constituted by the Hon'ble Vice-Chancellor, NBU with Prof. Sanchari Roy Mukherjee, Dept. of Economics, NBU & Former Vice-Chancellor, Dakshin Dinajpur University to identify and recommend names of internationally acclaimed national and international

scholars and academicians who can be invited as Visiting Professor. The scholars and academicians would render their services in an honorary capacity and their association with the University would be subject to necessary clearances/permission from their respective institutes/universities as well as the necessity of obtaining any formal permissions under the rules in force in India. As recommended by the Committee, the goal of the Scheme to invite professors and academicians to –

- Deliver formal lectures through online and/or offline mode for at least 10 hours of lectures per semester
- Mentor PG students and Research Scholars through formal or informal discussions
- Act as Co-supervisor of Research Scholars
- Undertake collaborative research with the Departmental Faculty
- Present papers at University's seminar/conferences

The Committee in its meeting recommended few names of eminent academicians and also sought nominations from each of the academic Departments in the respective field expertise. Based on this, and after scrutinizing the profile, the following 113 names have been finalized initially. The list includes eminent national academicians across the country and foreign academicians across the globe. Consent of the invited Professors has already been taken from these scholars informally through the academic Departments of NBU. Formal invitation will be done in due course.

The University is further considering another 100 names received, and suitable names from these will be selected in phases. Moreover, the constituted Committee would be continuously identifying the best talent and recommend names to broaden the specialization.

The International Visiting Professors Scheme will be implemented through the Office of the Development Officer, NBU where the Development Officer will be the Nodal Officer for the scheme. The following three teachers will coordinate the scheme in close association with the Development Officer. A detailed terms of reference will be formulated by the University in this regard. –

Resolved that Executive Council requests the state government to assume the responsibility for the payment of salary/remuneration of the casual and contractual non-teaching staffs and the payment for the teachers engaged in contractual positions. Further resolved that Dean, Faculty Council for PG Studies in Arts, Commerce & Law and the Finance Officer be requested to prepare back up note to place the financial liability of the University in the Higher Education Department, Govt. of West Bengal in consultation with the Dy. Finance Officer & Joint Registrar.

He shall be supported by a core team of researchers—Dr Souryadeep Sen, Dr Verma Priyadarshini, Dr Binayak Sundas and Shri Adwaita Thapa. The Director and the core team is authorised to finalise all modalities and contours of the collaborative research together with the Indian Army and other organisations. It was also resolved to approach Indian army to support the Centre with a corpus of fund. Finally, the Executive Council also resolved to provide a sum of Rs. 20 lakhs as seed money from the University fund to the Centre for carrying out the work of setting up of the centre and consultation/seminar/conferences etc.

The qualification and consolidated salary will be in accordance with University of North Bengal as per UGC guidelines The salary of the contractual staff shall be claimed from UGC. If any contractual appointment has already been made the same may be continued be fitted with the existing staff pattern and emolument as per UGC Guidelines. Also, If any advertisement for a non-teaching post as approved by the Govt. of West Bengal was made, the same will be kept outside the contractual appointment process. Registrar is authorised to comply all necessary formalities as required to fill up the abovementioned posts on contractual basis forthwith.




