## CIRCULAR

As per the order issued by the Honorable Vice-Chancellor dated 08.09.2021, it is notified for general information that:

- 1. The Festival Advance @ Rs. 25000/- ( Rupees Twenty Five Thousand ) only has been approved for payment to all the Permanent Teachers, Officers and Non-Teaching Employees of the University which will be recovered in 10 (Ten) equal monthly installments w.e.f. November, 2021 from their salary , however those who would be retiring before recovery of the entire amount , the unrecovered balance shall be adjusted with their retirement benefits.
- 2. On the other hand, the Festival Advance to the extent of Rs. 25,000/- (Rupees Twenty Five Thousand ) only or one month's Consolidated Remuneration whichever is lower has also been approved for payment to all the Contractual Employees whose remuneration are borne out of the State Govt. and / or University Fund. The said advance will be recovered from their monthly Consolidated Remuneration in 10 (Ten) equal installments w.e.f. October, 2021. However, and undertaking as per the enclosed proforma is to be given by the Contractual Employees in a Nonjudicial stamp paper worth Rs. 10/- to the effect that they will be liable to refund the Festival Advance as per rules of the University in the event of resignation or non renewal of contract, failing which appropriate action will be taken against them by the University. The said undertaking should be submitted within 18.09.2021.
- 3. The Festival Advance is expected to be disbursed on 21.09.2021 through Bank Advice to the eligible persons as above, however, those who are not willing to draw the same my intimate to the undersigned in writing within 18.09.2021 positively otherwise the amount will be disbursed as aforesaid.
