Minutes of the 71st meeting of the Executive Council held on 25.11.2022 at 12.00 noon in the Meeting Room of the Hon'ble Vice-Chancellor, University of North Bengal.

Leave of absence was granted to Director of Public Instruction, Govt. of West Bengal, Sri Siladitya Basu Ray, Special Commissioner, Higher Education Department, Prof. Shanti Chhetry, Vice-Chancellor, University of Gour Banga and Principal, P.D. Women's College. It was noted that the term of the Chancellor's Nominee – The Vice-Chancellor of NSOU Professor Ranjan Chakraborty has expired.

Professor Rathin Bandyopadhyay, requested that agenda and the relevant papers should be sent to the members in due time. The Chairman requested the Registrar and Secretary, Executive Council to do the needful in this regard in future.

Decision: Noted and approved. The Hon'ble Vice-Chancellor and the Chairman reported that the following two committees i.e. Vision Document on NBU Jalpaiguri Campus and the formation of the Committee on DDE issue could not materialise as per resolution of the last Executive Council meeting. This would be undertaken as soon as possible.

3. To note the decision in the Cabinet, Govt. of West Bengal held on September 19, 2022 on the Proposal for transfer of user right in respect of 5.00 acres of land at North Bengal University Campus for setting up of an Institute of Hotel Management in NBU Campus.

Discussion: The Hon'ble Vice-Chancellor, NBU and the Chairman, Executive Council, NBU, presented the detailed background of the decision of the Cabinet of Government of West Bengal on the subject of setting up of an institute for imparting courses and programmes on hotel management. He categorically stated that the proposed institute is going to be a government controlled institution. There is no company or corporate entity involved. The proposal has the following background:

- ❖ On 08.11.2019 the Executive Council of the University under Item No. 4(vi)(d) resolved to send a proposal to the Department of Higher Education for a sanction of grants of Rs. 15.00 crore for the opening of a programme of Hotel and Tourism Management at North Bengal University vide letter No. 1096/R-19 dated 08.11.2019.
- ❖ On 03.12.2019 the University was informed by the Department of Higher Education that an Expert Committee has been formed for considering all the aspects vide letter dated 27th November, 2019.
- ❖ On 23.12.2019 the said Committee met at NBU Kolkata Camp Office and prepared a Report for submission before the Department of Higher Education with the commitment to identify five acres of land at NBU Campus along with other relevant information and sent the same to the Principal Secretary to the GoWB, Department of Higher Education vide letter No. 52/R-2020 dated 15.01.2020.

- ❖ On 27.10.2021 the University sent a letter of request to the Department of Higher Education, GoWB expediting the process of establishment of the said course at NBU and to make a policy decision vide letter No. 530/R-21 dated 27.10.2021.
- ❖ During the month of March, 2022 a team comprising Hon'ble Vice-Chancellor, District Magistrate of Darjeeling, Estate Officer, NBU visited the proposed site and identified the land of about 5 acres in the Northern part of the Campus.
- ❖ Following a meeting between the Vice-Chancellor in-Charge (Dean Science), Registrar (Officiating), Joint Registrar and others as well as Tourism Department Official, Sri Jyoti Ghosh from the office of the Tourism Department, Siliguri visited the proposed area and the land identified by the BLRO (Memo No. 944, Dated 14.02.2022) about 12 acres of land from a piece of 44.60 acres under LR Khatian 370 of which 6.5 acres were under Rubber and Tea Plantation leaving 4.5 acres free and vacant and 1 acre of land with old tea bushes. The copy of the sketch map was shared with the BDO.
- ❖ The Department of Tourism proceeded to prepare the DPR and shared the details with the University through the Deputy Secretary, Department of Tourism (No. 584-DT/TM-15013(99) dated 20.06.2022.
- ❖ On 14.10.2022 a draft MOU for establishing State Institute of Hotel Management was shared by the Department of Tourism for initial signing by the University Nominee and Representatives of the Higher Education Department and Tourism Department. The University intends to proceed further on the basis that no cost of infrastructure development is to be incurred by the University and the Department of Higher Education has the concurrence in the use of earmarked land by the Department of Tourism, Government of West Bengal at the initial stage after which further arrangements may be considered.
- ❖ On 19.10.2022 the University received a letter vide No. 526-EDN/NCC/1L-01/2022 (Part) intimating the approval of the proposal by the Cabinet of Government of West Bengal on 19.09.2022.
- ❖ Later the University sent a four member Study Team at the State Institute of Hotel Management, Durgapur comprising three teachers and one officer under the Chairmanship of Professor Arnab Sen, a senior Professor of the University, Department of Botany to submit a report on the activities, programme and management structure of SIHM, Durgapur.

- ❖ The Study Team on completion of their visit on 09.11.2022 submitted a report which was placed before the Executive Council on 25.11.2022 wherein it has been categorically mentioned that SIHM is under the affiliation of the NCHMCT under the control of the Department of Tourism, Govt. of West Bengal and there is no private participation and control of any private players or companies in whatsoever matters of the Institution, whether regulatory, academic or otherwise.
- ❖ In the said Decision in the Cabinet it has also been found that in compliance of the Legal aspects, Financial aspects and the Land and Land Reforms Departmental aspects the decision was as under:

"The Higher Education Department now proposes for approval of the proposal as enclosed with the Cabinet Memorandum for granting user right of 5.00 acres of land in favour of the State Institute of Hotel management, Siliguri by the North Bengal University for setting up the State Institute of Hotel Management at North Bengal University Campus and for permitting the North Bengal University and the State Institute of Hotel Management, Siliguri to execute the proposed MoU as enclosed, with the Tourism Department and the Higher Education Department as confirming parties."

On completion of the brief presentation, the Chairman, Executive Council requested the members to share their observation and opinion in this matter. Accordingly, each and every member presents in the Meeting placed their opinion one by one.

- (i) Principal, University B.T. & Evening College: It is the Decision in the Cabinet, Govt. of West Bengal. We should counter the misgivings on this issue.
- (ii) Dr. John J. Georrge, Head Department of Bioinformatics: It is the Decision in the Cabinet, Government of West Bengal and there is no reason not to accept.
- (iii) Dr. Sujit Ghosh, Principal, Siliguri College expressed the same views as above.
- (iv) Dr. Mayukh Sarkar, Principal, APC, Govt. College: It shouls a fully Government organisation. It is a very good concept which will cater to the needs of the youth of this region. Moreover, it is the Decision in the Cabinet, Govt. of West Bengal.
- (v) Dr. Ganeshji Tiwari, Principal, IILS: It is going to be a Government organisation. He mentioned that there is an institute in Sikkim also. Moreover, job opportunities can be created.
- (vi) Principal, Maynaguri College: It is a demanding course, and students will largely be benefitted if such an institute is opened in the NBU Campus.

- (vii) Dr. Anoop Kumar, Head, Department of Bio-technology: It will be beneficial for the University. An area has already been earmarked. Students from across all over India will take admission through Joint Entrance Board.
- (viii) Dr. R. P. Dhakal, Principal, Kalimpong College: It is a technical matter but since a Decision in the Cabinet, Govt. of West Bengal has already been taken, University need to respect.
- (ix) Professor Utpal Mandal: It is good to start an academic institute. There may be some communication gap, I think. However, the entire process has been done in compliance of the Legal aspects, financial aspects and the Land and Land Reforms Departmental aspects.
- (x) Prof. Dyutis Chakraborty: The proposal was mooted by the NBU in 2019. Dissemination of knowledge, training up of students and teachers, vocational training would benefit as the institute would be under the aegis of the State and Central Government bodies.
- (xi) Professor Rathin Bandyopadhyay, Dean, FC of Arts, Commerce & Law: I do not support the way it is being done. Legal opinion is taken or not? A lot of clarity is required. There are plenty of land, why it is in the University?In his opinion, the decision in the Cabinet should have been "Noted" only.
- (xii) Professor S. C. Roy, Dean, FC of Science: I request all the members to go through the details of the papers started since 2019. It is the Decision in the Cabinet, Govt. of West Bengal and it seems that legal opinion was obtained by the Government.

 It was clarified by the Chairman that the land earmarked by the University is not at all in the front of the University and that there is no provision in the proposed MOU to involve any private company or corporate entity. He also pointed out that both the Higher Education and the Tourism Department of Government of West Bengal, would be confirming the proposed MOU.

Decision: After threadbare discussion on this issue it is resolved to Note the Decision in the Cabinet, Govt. of West Bengal dated 19.09.2022 and undertake all necessary follow up actions including signing of an MOU. It was also decided that the MOU would clearly stipulate that land would be under the ownership of the University.

Out of the total number of twelve members all accepted the decision except for Prof. Rathin Bandyopadhyay. His reservation is noted.

Registrar (Offg.) be requested to take necessary action. **Confirmed with immediate effect.**

4. To note the letter received from the Hon'ble Chancellor, NBU and Governor of West Bengal regarding the meeting of The Court, University of North Bengal.

Decision: Noted.

5. To consider the reconstitution of the Research and Development Cell in the University in compliance with UGC Guidelines vide no. 1-5/2021(NEP/Desk-parl) dated 29.04.2022.

Decision: Resolved that Prof. (Dr.) Pranab Ghosh, Department of Chemistry be nominated as the Director of the Research and Development Cell of the University of North Bengal. On several occasions UGC requested the University Authority to implement the Guidelines for establishment of Research and Development Cell in Higher Education Institutions which pave the way for integrating the key elements – Research, Innovation and Technology Development of India. Considering the importance and urgency of the matter the Executive Council proposes the name of Prof. (Dr.) Pranab Ghosh, Department of Chemistry as the Director of the Research and Development Cell of the University of North Bengal, keeping in mind his vast experience of Teaching and Research and his administrative experience of performing additional duties of the Post of Registrar of this University. Prof. Ghosh is requested to suggest formation of various committees related to the Cell for taking future course of action from the part of the University.

Development Officer be requested to take necessary action. Confirmed with immediate effect.

6. To consider various issues related to Solar Power plant instituted by the North Bengal Development Department, Govt of West Bengal at NBU Main Campus.

Decision: The Chief Engineer of the University of North Bengal apprised the members the background history of the Solar Power plant issue and the outcome of the meeting with the Principal Secretary, NBDD and the Chief Engineer, NBDD with the officials of North Bengal University in the presence of the Hon'ble Vice-Chancellor. The University raised questions both related to the activation of the Solar Panel and the damage to the roofs of the various buildings. University requested that the NBDD should reimburse the expenses related to the repair and restoration of the roofs of the several buildings and also undertake the remaining work of repair and reconstruction. The NBDD officials pointed out that they did not receive necessary cooperation and that they are short of funds. Hon'ble Vice-Chancellor and the Principal Secretary, NBDD have asked both the sides to work together and it was decided in the meeting Solar Panel would be activated within 28th February 2023.

Registrar (Offg.) be requested to take necessary action. **Confirmed with immediate effect.**

7. To consider the proposed MoU between Institute of Language Studies and Research (ISLR), Kolkata, Department of Higher Education, Govt. of West Bengal with the UGC-HRDC, NBU.

Roy, Dean, Faculty Council for PG Studies in Science, Professor Ranadhir Chakraborty, Department of Biotechnology, Professor Anoop Kumar, Head, Department of Biotechnology and Dr. S. N. Saha, Finance Officer (Offg.) of the University have agreed to follow various steps and procedure to take forward the proposal. The Executive Council decided to constitute a Committee of the above teachers to finalise terms and conditions with the Dean, Faculty Council of Science as Chairperson and Head, Department of Biotechnology as Convener in this regard.
