#### INTRODUCTION

The University of North Bengal was established by an Act of the Legislature of West Bengal in 1962 with the mission "to encourage and provide for instruction for teaching, training and research in various branches of learning and course of study; to promote advancement and dissemination of knowledge and learning and to extend higher education to meet the growing needs of society."

The University of North Bengal campus covers an area of nearly 315.99 acres of land at the foothills of high Himalaya in close proximity of vast plains around it with a fascinating glimpse of the Kanchenjunga peak, tea gardens and forest cover.

# **HOSTEL**

#### Vision

To provide an abode of ideal ambience through happy housing, nutritious nourishment, and caring counselling to prepare the youth to carve out their careers.

#### **Mission**

UNIVERSITY OF NORTH BENGAL strives to render its unique service to the ambitious youth by providing facilities like good accommodation, food and instruction through its institutions including the Hostel.

## **ELIGIBILITY**

- a) Accommodation in the University Hostel is available only to bona-fide students of full time courses.
- b) Applicants must have passed with a minimum of marks in aggregate in the last qualifying examination.
- c) As seats are limited in the hostels, students whose distance of home to University campus is within 45 KMs are not necessarily eligible for the hostel accommodation.
- d) There are also facilities available for the Physically Handicapped students (PH Students).

### **ADMISSION PROCEDURE**

- a) Students seeking admission to the hostel must apply by filling the prescribed Application Form available on the NBU official website.
- b) Admission to the hostels is exclusively on the basis of merit as per specified in the Admission Criteria.
- c) Distance to be determined based on Permanent Address/residential address.
- d) Income Certificate issued by competent authority must be produced.
- e) For Law Hostel (Boys' & Girls') Admission done through the recommendations of Hostel Advisory Committee of Dept. Of Law, NBU.
- f) All rules and regulation of the hostel will apply equally to foreign and NRI students.

### **HOSTEL RULES**

- 1) Boarders will return to their respective Hostel by 9.00 PM
- 2) Boarders must be return in their respective room by 10.00 PM
- 3) For Girls' Hostel, entry time in Hostel at night is 8 pm (Summer) and 7.30 pm (Winter).
- 4) Meals will not be served after 9.00 PM. (Dinner).
- 5) Boarders will pay the mess advance by the 10th day of every month. A fine will be decided by the competent authority will be imposed for each day of delay in payment.
- 6) The residents are required to take meals only in the Hostel Dining Hall.
- 7) Dining Hall timings shall be fixed as notified from time to time. All residents shall adhere to these timings. Dining Room timing is

#### Morning: 9.15 am to 10.15 am

#### Evening: 8.00 pm to 9.00 pm

- 8) Boarders will not keep guests in the Hostel without prior permission of the Superintendent. Guest, if allowed, will not be allowed to stay for more than three successive days.
- 9) Boarders will not leave the Hostel for home or any other without prior intimation to the Superintendent. The intimation must be given in writing and the application must contain his/her address and phone number.
- 10) Member of opposite sex are not allowed to enter in to the Hostel. & Taking of drugs and other intoxicating substances are strictly prohibited within the Hostel premises.
- 11) Boarders will not be allowed to use heaters, iron etc. in the room
- 12) Boarders will not be allowed to stay in the Hostel during Puja Vacation and Summer Vacation.
- 13) Boarders will not create any disturbance or indulge in any act of violence or misbehaviors, which may vitiate the sound congenial atmosphere in the hostel.
- 14) Boarders must stay in the assigned room of the hostel allotted to them. Violations of this will be expelled from the Hostel.
- 15) Boarders will be responsible for the properties of the room. They must handover all the properties at the time of leaving either to the Superintendent or his/her representative.
- 16) All sorts of ragging are strictly prohibited. Any sort of ragging will be dealt with as per UGC Regulations/relevant Supreme Court Judgment or as the competent authority deems fit.
- 17) Boarders will have to carry out their assigned mess duties/managerial responsibilities for g particular month. No adjustments will be entertained.

- 18) No boarder will be allowed to take meals in their room.
- 19) No boarder will be allowed to cook food in their room
- 20) In all others matters, not covered here, the decision of the Superintendent/Board of Residence & Discipline will be binding on the Boarders.
- 21) Mess is supervised by students of respective hostel with the guidance of the respective Superintendent. Mess representatives are elected by Hostel Residents.
- 22) Carrying of Mess articles/plates to the rooms and common places is strictly prohibited.
- 23) Boarders are required to be properly attired in the Dining Hall.
- 24) Boarders are requested to keep the dining hall clean.
- 25) Food shall not be taken out of the Dining Hall. Only sick boarders may be allowed by the Doctor/Warden to have light meals in their rooms on written advice of the University doctor.
- 26) Room-mates are not allowed to take food on behalf of absentees.
- 27) The hostel mess may not function during the vacation for those who are permitted to stay in the hostel. If the mess functions, the charges would be as per arrangements made.
- 28) Boarders are requested to maintain discipline in the dining room as well as they are requested to cooperate with the mess staff.

### **RAGGING**

Ragging in all its forms is totally banned on the premises of the University and its hostels.

Any student indulging in ragging will be expelled.

As per University Grants Commission Letter No. F 1-16/2007 (CPP-11), dated: April, 2009 related to UGC Regulation on curbing the menace of ragging in higher educational institutions 2009, the students are advised to take note of the following:

As per the orders of Hon'ble Supreme Court of India 'Ragging' means the following:

"Any conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other students, indulging in rowdy or indiscipline activities which causes or is likely to cause annoyance hardship or

psychological harm or to raise fear or apprehension thereof in a fresher or a junior student or asking the students to do any act or perform something which such student will not do in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student".

#### **Punishable Aspects of Ragging:**

- Abetment to ragging
- Criminal Conspiracy to rage
- Unlawful assembly and rioting while ragging
- Public nuisance created during ragging
- Violation of decency and morals through ragging
- Injury to body, causing hurt or grievous hurt
- Assault as well as sexual offences or unnatural offences
- Wrongful restraint/ Wrongful confinement / Use of criminal force
- Extortion / Criminal trespass
- Criminal against property / Criminal intimidation

Strict action shall be taken against those found of ragging and/or abetting ragging.

Each resident shall have to sign an undertaking to the effect that she is aware of the law prohibiting ragging as well as the punishments and to the effect that she has not been expelled and/or debarred from admission by any institution on these grounds and that she if found guilty of the offence of ragging and/or abetting ragging, is liable to be punished appropriately.

An undertaking shall also be signed by the parent/guardian of the application the effect that he/she is also aware of the law in this regard and agrees to abide by the punishment meted out to her ward in case the latter is found guilty of the offence of ragging and/or abetting ragging is liable to be punished appropriately at the time of joining the hostel.

**Punishment:** Depending upon the nature and gravity of the offence as established by the Anti-ragging committee of the institution, the possible punishments for those found guilty of ragging shall be any one or any combination of:

- 1) Suspension/Expulsion from the hostel
- 2) Cancellation of admission
- 3) Rustication from the institution
- 4) Debarring from admission in the hostel in future
- 5) Collective punishment: When the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment.
