Detailed Information and Qualification for Officer Posts

1. Deputy Controller of Examinations: 1 post [UR]

[Pay Level 12: 79800 - 127900]

Essential Qualifications:

i. Uniformly good academic record with a Master's Degree with minimum 55% marks or its equivalent grade in the

point scale wherever a grading system is followed.

ii. At least 10 (ten) years of experience as Lecturer / Assistant Professor in the AGP of Rs. 6000/- and above with experience in educational administration in Academic Institutions like University, Research Establishment and / or in an institute of higher learning of which 5 (five) years must be in a University or in an Institute of Post Graduate Study.

OR

Comparable experience in research establishments and other institutions of higher learning.

OR

10 (ten) years administrative experience, of which 5 years shall be as Assistant Registrar or equivalent post.

ii. Age not less than 35 years. Relaxable in case of exceptionally qualified candidates.

Desirable Qualification:

i. A Doctorate Degree or published papers of high standard

OR

ii. Experience of at least 10 years in a fairly senior position in any academic institutions like a College or a University or a research organization.

iii. For Deputy Controller of Examinations it is essential to have experience of at least 3 years in conducting of examinations in either undergraduate teaching institution or equivalent.

2. Technical Officer - II: 1 post [UR]

Essential Qualifications:

i. M.E. / M.Tech. in Electrical & Electronics, Mechanical or Computer Science & Engineering or M.Sc 1st Class (60%) in Physics with Electronics or Instrumentation Science or Computer Science & Application with 5 years experience in the rank of Technical Officer – I in related disciplines. In the case of internal candidates the 1st Class M.Sc may be relaxed up to 50% marks along with 5 years experience in the rank of Technical Officer – I in related disciplines.

Provided that in absence of suitable candidates having the required administrative experience, if the candidate has been either a Professor / Reader / Principal / Lecturer for at least two years, the essential qualifications pertaining to administrative experience required for such post may be reduced or waived on recommendation of the Standing Committee. For candidates having required administrative experience, the essential academic

qualifications may be relaxed on recommendations of the Standing Committee, but the selected candidate must have at least the academic qualifications prescribed for Teachers of Colleges.

Provided further that in case of employees of the University who are otherwise found suitable, the prescribed academic qualification may be reduced or waived on recommendation of the Standing Committee.

At least 10 (ten) years of experience as Lecturer / Assistant Professor in the AGP of Rs. 6000/- and above with experience in educational administration in Academic Institutions like University, Research Establishment and / or in an institute of higher learning of which 5 (five) years must be in a University or in an Institute of Post Graduate Study.

Essential Qualifications:

- iii. Uniformly good academic record with a Master's Degree in Physics with specialization in Nuclear Physics and Cosmic Ray / High Energy Cosmic Ray Physics with minimum 55% marks or its equivalent grade in the point scale wherever a grading system is followed.
- iv. Ph.D. in Physics preferably in the field of High Energy & Cosmic Ray Physics / High Energy Physics (Experimental).
- v. Minimum 10 (ten) years of Research experience in experimental Research in High Energy Cosmic Ray Physics / High Energy Physics of which, at least 3 (three) years should be in the pay scale of Reader or equivalent.
- vi. Should be actively engaged in research with evidence of published research work of high quality.
- vii. Maximum age limit-50 years. Relaxable in case of exceptionally qualified candidate.

<u>Desirable Qualification</u>:

i. Experience in handling research projects in the field of High Energy / Cosmic Ray Physics and also experience in supervising research students.

5. Development Officer – 1 Post (UR)

Essential Qualifications:

- i. Uniformly good academic record with a Master's Degree with minimum 55% marks or its equivalent grade in the point scale wherever a grading system is followed.
- <u>ii.</u> At least 10 (ten) years' experience in a position involving supervision, control and planning of administration of colleges, Universities / Institutes of Higher Learning or Government of Quasi Government organization.
- iii. Age not below 35 years. Relaxable in case of exceptionally qualified candidates.

Desirable Qualification:

- i. A Doctorate or published work of high standard.
- ii. Experience of at least 7 years in University or in Post Graduate Research organization as Assistant Registrar or equivalent post. In that case, records of performance will be examined.

General instructions to the candidates

- i. Candidates applying for more than one post will have to apply in separate **Application Form** meant for the purpose.
- ii. Abbreviations used UR Un-Reserved, SC Scheduled Caste, ST Scheduled Tribe, OBC Other Backward Class, PH Physically Handicapped.
- iii. Application fees :Rs. 2000/- for the posts in Pay Level : 14, (Rs. 1000 for SC/ST/ OBC-A / OBC-B / PH Candidates), Rs. 1500/- for the posts in Pay Level 12 (Rs. 750 for SC/ST/ OBC-A / OBC-B / PH Candidates), Rs. 600/- for the posts in Pay Level 10 (Rs. 300 for SC/ST/ OBC-A / OBC-B / PH Candidates). Fees may be submitted through online mode only.
- iv. Persons employed in Government / Semi-Government / Quasi-Government / Autonomous bodies should submit their application through proper channel. They may, however, send an advance copy of the application. Those who are unable to process their application through proper channel may submit a 'no objection certificate' from the present employer at the time of the interview. However, they should also submit an undertaking to that effect along with the application form. No direct application from such candidates will be entertained.
- v. For reservation of OBC, SC, ST the certificates issued by the competent authority within the state of West Bengal shall only be considered valid. Such certificates issued by other states shall not be considered for the purpose of reservation. However such candidates may apply as unreserved candidates.
- vi. Proof of belonging to SC or ST or OBC or Persons with Disability must be uploaded along with the filled in Application Form and no claim in this regard will be entertained afterwards.
- vii. Age will be calculated as on date of advertisement.
- viii. Incomplete applications, applications without self-attested copies of certificates, applications without the requisite fees, or applications received after the due date are liable to be rejected.
- ix. The University shall not entertain any application after the last date.

- x. The University shall reserve the right to cancel the process of recruitment to any category of the above mentioned post(s) without showing any reason whatsoever.
- xi. The University reserves the right of rejecting any or all the applications without assigning any reason thereof.
- xii. Mere eligibility will not vest any right on any candidate for being called for interview / in any other form of selection process. Only the short listed candidates will be called for interview. The decision of the University in all matters will be final.
- xiii. No informal correspondence from the candidates will be entertained in connection with the process of selection. Canvassing in any form will entail disqualification of Candidature.
- xiv. Supporting documents showing the details of past service in U.G.C. scale must be provided.
- xv. Application fee once paid shall not be refunded under any circumstances.
- XVI. A relaxation of 5% in the marks may be provided for the candidates belonging to SC / ST / Differently abled (Physically as well as visually) categories.
