- b) **EMD –A sum of Rs.1000.00 (rupees one thousand)** in the form of CTS Demand Draft from any Nationalized Bank in favour of University of North Bengal payable at Siliguri is to be attached/uploaded with the tender documents as earnest money deposit, failing which the tender/quotation will be treated as cancelled.EMD will be released after expiry of one year from the date of successful delivery of the material in case of selected bidder.
- c) **Price should not exceed MRP/Latest price-list of the manufacturer and should be including of all taxes.**
- d) Quoted rate should be valid for at least 4 (four) months.
- e) Time of delivery shall be reckoned 10 (ten) days from the date of receipt of work order.
